



## ERRATA to the FIDIC Client/Consultant Model Services Agreement Fifth Edition 2017 [ISBN 978-2-88432-078-8]

The following significant errata **are not** included in the content of the Fifth Edition of the Client/Consultant Model Services Agreement. Several minor typographical errors and layout irregularities have also been found but are not included in this list due to their insignificance with regard to the content.

### GENERAL CONDITIONS

Page 4	Sub-Clause 1.5.2:	On the fourth line, replace “services” with “Services”.  From the ninth to eleventh line, delete the sentence from “Either Party” to “where applicable” in its entirety.
Page 4	Sub-Clause 1.5.3:	Add a new Sub-Clause 1.5.3 as follows:  “Either Party may require, by a separate Notice to the other, that the provisions of the Agreement be amended to comply with the change in legislation where applicable”.
Page 8	Sub-Clause 2.1.2:	On the sixth line only, replace “Standard of Care” with “standard of care”.
Page 8	Sub-Clause 2.4.2:	On the second line, replace “detailed particulars” with “supporting particulars”.
Page 15	Sub-Clause 6.1.2(c):	At the end of the sentence, replace the full stop with a comma and add “subject to the Consultant giving seven (7) days’ notice to the Client”.
Page 16	Sub-Clause 6.3.3:	Delete the entire Sub-Clause 6.3.3 and replace it with the following:  “6.3.3 If, during the suspension and resumption of Services or part thereof, the Consultant incurs Exceptional Costs, then: (a) as soon as reasonably practicable the Consultant shall inform the Client, by issue of a Notice, of the occurrence of these Exceptional Costs, and (b) the agreed remuneration shall be adjusted in accordance with Sub-Clause 7.1.2 [ <i>Payment to the Consultant</i> ]”.
Page 16	Sub-Clause 6.3.4	Delete the entire Sub-Clause 6.3.4 and replace it with the following:  “6.3.4 The Time for Completion shall be amended in accordance with Clause 4.4 [ <i>Delays</i> ] to reflect the effect of the suspension on the Programme.”.
Page 16	Sub-Clause 6.3.5:	Add the following new sub-clause 6.3.5:  “6.3.5 The Consultant shall take reasonable measures to mitigate the effects of the suspension of the Services or part thereof.”.
Page 16	Sub-Clause 6.4.1(e):	On the first line, delete the phrase “Without prejudice to Sub-Clause 6.1.1 [ <i>Suspension of Services</i> ],” in its entirety.  On the second line, replace “where” with “Where”.
Page 19	Sub-Clause 7.3.2(c):	From the sixth to ninth line, delete all the words from “then the Client agrees that... ..to the satisfaction of the Consultant.” and reintroduce the same wording as a new paragraph below, and applying to all of Sub-Clause 7.3.2.
