From 2013 she changed her position to Marketing Manager, in order to allocate more time to construction law, focusing on training, claims management and dispute resolution under FIDIC contracts. From 2015 she teaches Project Management with FIDIC Conditions of Contract at the University of Architecture, Construction and Geodesy. In the last 3 years she has been the Planning and Contracts Key Expert in the preparation of railway projects with 1 billion EUR budget.
