EXPERIENCE

After several years in one of the major Spanish construction companies providing legal and contractual support to all type of engineering and construction projects, Mr. Laorden joined James R. Knowles, international construction contracts consultants with offices in over 20 countries, opening and managing their Spanish office for over 5 years. Following this period Mr. Laorden opened a Law Firm specialised in construction and engineering law.

Among his clients there are some of the largest Spanish construction and engineering companies, architectural firms, and major industrial equipment providers, both Spanish and from other nationalities.

Mr. Laorden has been involved in a great variety of projects, including building, civil works, telecommunications, energy (power plants, including combined cycles, cogeneration, nuclear, solar; transmission lines, substations, etc.), oil & gas, ship construction, off-shore projects, water industry, waste treatment plants, desalination plants, etc., drafting contractual documents, providing legal and contractual advice and other services such as Contract Administration and Claims Management, and participating in dispute resolution including ADR, litigation and arbitration.

He represents clients in ADR, litigations and arbitrations, including Dispute Boards and ICC arbitrations. He acts as counsel and/or arbitrator and/or Dispute Board member in mediations, arbitration and dispute board process in Spain (Corte de Arbitraje de Madrid, Corte de Arbitraje ICAM) and internationally (ICC Arbitration and Mediation Rules).
