I am a Civil Engineer with more than 30 years professional experience as a designer, construction manager and consultant.

As Head of Logistics Department, Construction Manager, later Head of Tender and Contracts Department in the biggest steel structures contractor in Bulgaria Metalni Construczii for more than 10 years, I managed international contracts in Bulgaria, Israel, Serbia, Russia and Greece.

From 1998 I started my career as a consultant in the supervision of works under the first FIDIC contracts, implemented in Bulgaria in the Kozloduy NPP. In 2000 I founded EQE Control as a company of EQE International (acquired by ABS Group in 2004). I continued my career as a Partner and Managing Director of the company, focusing mainly on project management of complex international projects. I managed the consulting services for the biggest project in Bulgaria: 600 MW TPP AES Galabovo (1,4 billion EUR), 156 MW St Nikola Wind Park Kavarna, 176 m high Europe Tower Sofia, Business Park Varna, 6 World Bank Cross-Border projects.

I have more than 20 years FIDIC experience: preparation of tender documentation; Resident Engineer/ Engineer in nuclear safety/ waste management/ infrastructure EC financed projects; claims consultant; presently DAB.

From 2013 I changed my position to Marketing Manager, in order to allocate more time to construction law, focusing on training, claims management and dispute resolution under FIDIC contracts.

In the last years, I was involved as a contracts manager in high speed railway projects in Bulgaria for more than 1 billion EUR, co financed by CEF (Connecting Europe Facility). From 2015 I am teaching PMBOK (the PMI project management standard) and FIDIC to the MSc at the University of Architecture, Construction and Geodesy in Sofia.

As a FIDIC Accredited Trainer I delivered many trainings in Bulgarian and in Russian in Bulgaria, Kazakhstan, Russia, Belarus, Ukraine, Uzbekistan, Tajikistan.

Chairing the BSCL, I am leading a FIDIC Task Group, issuing Particular Conditions and guidance for the use of the FIDIC Red and Yellow Books in Bulgaria, also advising the translation of the 2017 FIDIC White, Red and Yellow Books. I manage another Task Group which adapted the modern standard form *Framework Alliance Contract FAC-1*, issued in 2016, used for procurement in the amount of more than 14 billion pounds in UK and Italy and to be used for the first time on our project for the German Embassy in Sofia as an umbrella to FIDIC contracts, in parallel with an EBRD project in Kazakhstan.

As a DRBF Region 2 Director I organised trainings and mock DABs to promote dispute boards in Bulgaria, Macedonia, Ukraine, Kazakhstan and Russia. Also, I am a member of the new DRBF Mentoring Committee, which designed a new "DRBF-facilitated mentoring Scheme" to assist members to acquire first-hand knowledge and experience in the operation of Dispute Boards.
