- ACEG has the Code of Ethics based on the FIDIC Code of Ethics and principles of professional integrity. ACEG requires from its members to:
 - Act in the best interest of his/her client and the project;
 - Be independent in the professional activity and not be influenced in any way by the relationships with other persons or organisations;
 - Be competent, having the relevant experience necessary for accomplishment of the mission;
 - Undergo permanent professional training, which means, among other things, participation in courses or events in the relevant field.

- Voting Members
 - Any natural or legal person who gains revenues from providing consulting engineering and/or architectural services, who adheres to the Code of Ethics and the principles of professional integrity.

- Honorary Members
 - A natural person with important contribution to the Association and/or to the profession.
