Announcement of the Certification of the 3rd Group of FCCE Candidates and Notification of the Collection of Examination and Certification Fees

Dear participants of the 3rd FCCE examination and certification programme,

In accordance with the "Notice of the CNAEC on the 3rd FCCE Examination and Certification" (CNAEC International [2019] No. 87), the FCCE Certification Management Board (hereinafter called "the FCCE Board") organized the 3rd FCCE examination in Beijing, Hangzhou and Guangzhou respectively, from 30 November to 1 December 2019.

Following the assessment of the examination papers and a review of the certification materials submitted by each candidate, the FCCE Certification Management Board has determined that 447 candidates have passed the examination and certification programme. The 3rd group of FCCE candidates who have successfully completed the programme can pay for the examination and certification fees after the termination of the announcement period.

Please make the payment of **CNY16,500** to the FIDIC entity in China notably, FIDIC Consulting Services (Beijing) Co. Ltd. before September 18, 2020. Upon receiving the fees, the FIDIC President will sign and issue the FCCE certificates, which will be printed and sent to each FCCE graduand. Furthermore, FIDIC will put the information of each FCCE graduand onto its official website www.fidic.org, subject to the his/her approval.
