

Present FIDIC Contracts Courses 21st - 25th November, 2016

OVERVIEW FIDIC

Conditions of Contract are now the international language in infrastructure projects throughout the world. The three courses have been designed to offer a complete and effective understanding on the management of contract claims and the resolution of disputes. The design-build obligation which provides a long term commitment by the contractor is intended to ensure sustainability of projects; while the FIDIC Procurement Procedures Guide provides the internationally accepted framework for project procurement.

Whist Module 2 provides practical advice to those working with the FIDIC Conditions of Contract in the management of claims, understanding, defending and achieving the resolution of disputes, Conditions of Contract for DBO Projects provide for award of a single contract to a single contracting entity (consortium or joint venture) rather than awarding separate contracts for design-build and for operation. On the other hand, the Procurement Guide provides a transparent and systematic approach to the procurement of engineering and building works. It encompasses the processes from identification of a project up to receipt of tenders and award of contract.

The courses provide the necessary knowledge for and targets professionals from Government Ministries and Agencies. Private Sector Employers, Consulting Engineers, Contractors, Quantity Surveyors & Architects, Legal Advisers and all involved in the implementation and management of large Works Contracts.

COURSE RECOGNITION

The courses are accredited by FIDIC. They are also accredited by the Engineers Registration Board of Tanzania and participants will be awarded 13.0 CPD Points for either Module 2 or DBO. The course on Procurement Guide attracts 6.5 CPD Points.

COURSE TUTOR

The tutor is Dr. Goetz-Sebastian Hoek. He is highly qualified and experienced in the use of FIDIC Contracts and has been involved in various infrastructure projects in Africa, the Middle East, South East Asia and Europe. Dr. Hoek is a specialist in International Contract Law, Construction law and International Litigation. He is an Arbitrator, Adjudicator and is listed in the FIDIC President's List of Approved Dispute Adjudicators.

REGISTRATION AND COURSE FEE

Delegate fee is USD 850.00 per person per course (for Module 2 and Design-Build Operate course). Delegate fee for FIDIC Procurement Guide is USD 425.00. The fees cover cost of refreshments, course materials and lunch. For 2 or more delegates from the same organization or a delegate who registers and pays the fee by 10th August, 2016 delegate fee is USD 800.00 (for Module 2 or DBO course). Early bird fee for Procurement Guide is USD 400.00.

A delegate who registers for Module 2 and DBO Projects will pay USD 1,500.00 while a delegate attending all three courses pays USD 1,900.00. Firms that sponsor more than 5 delegates and all attending two or more courses receive a discount of 10%.

Delegates can also pay in local currency using the exchange rate applicable on the day of payment.
