OVERVIEW

FIDIC Conditions of Contract are increasingly used by the International Construction Industry throughout the world. The courses have therefore been designed to provide a complete and effective understanding on the appointment and operation of Dispute Adjudication Boards, management of FIDIC Contracts as well as procurement, implementation and management of EPC/Turnkey Projects.

While Advanced Module 3 is designed to provide an in-depth understanding of Dispute Adjudication Boards, Module 4 is designed to enable professionals in the industry to have confidence in working with FIDIC documents as Project Managers and Contract Administrators. EPC/Turnkey Projects are recommended where an entity takes total responsibility for the design and execution of an engineering project i.e engineering, procurement and construction: providing a fully equipped facility ready for operation. The EPC course is recommended for delegates who have attended FIDIC Contracts course Module 1 i.e. **“Practical Use of the 1999 FIDIC Conditions of Contract”**

WHO SHOULD ATTEND

The courses target Government Ministries and Agencies, Private Sector Employers, Consulting Engineers, Contractors, Quantity Surveyors & Architects, Legal Advisers and All those involved with the implementation and management of large Works Contracts.

COURSE RECOGNITION

The courses are regarded by FIDIC as providing part of the appropriate training for any person wishing to apply to the National Adjudicators' lists, FIDIC the FIDIC President's List of Approved Dispute Adjudicators. The courses are also accredited by the Engineers Registration Board of Tanzania. An engineer attending Module 3A will be awarded 16.0 CPD Points. Module 4 also attracts 16.0 CPD Points while EPC/Turnkey Projects course is allotted 12.0 CPD Points.

COURSE TUTOR

The tutor is Dr. Goetz-Sebastian Hoek. He is highly qualified and experienced in the use of FIDIC Contracts and has been involved in various infrastructure projects in Africa, the Middle East, South East Asia and Europe. Dr. Hoek is a specialist in International Contract Law, Construction law and International Litigation. He is an Arbitrator, Adjudicator and is listed in the FIDIC President's List of Approved Dispute Adjudicators. His publications include translations (into German and French) of FIDIC Conditions of Contract (Red, Yellow and Pink Books) and *"Relationship between FIDIC Conditions of Contract and public procurement law - reliability of Tender Documents"*. Dr. Hoek is a law lecturer and senior partner of Rechtswalt, a law firm in Berlin.

REGISTRATION AND COURSE FEE
