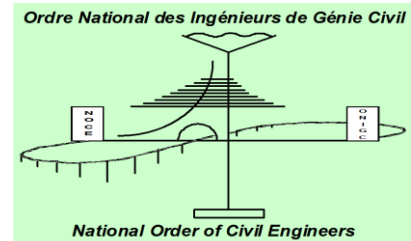

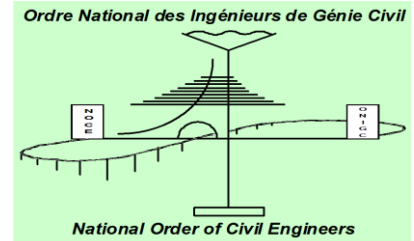

1. Registration: Delegate fee is €650.00 per course and it is **payable in advance**. For 2 or more delegates from the same organization or a delegate who registers and pays registration fee by 15th November, 2013 delegate fee is €620.00. A delegate who registers for both courses is €1,220.00.
